Veterans Administration Hospitals and Military Treatment Facilities will be considered for payment according to current legislation.
<b>Court-ordered treatment or hospitalization</b> , unless such treatment is prescribed by a Physician and listed as covered in this plan.
Professional <b>services or supplies received or purchased from</b> Yourself.
Custodial Care.
Inpatient or outpatient services of a private duty nurse.
Inpatient room and board charges in connection with a Hospital stay primarily for environmental change or physical therapy; Custodial Care or rest cures; services provided by a rest home, a home for the aged, a nursing home or any similar facility service.
Assistance in activities of daily living, including but not limited to: bathing, eating, dressing, or other Custodial Care, self-care activities or homemaker services, and services primarily for rest, domiciliary or convalescent care.
Inpatient room and board <b>charges in connection with a Hospital stay primarily for diagnostic tests</b> which could have been performed safely on an outpatient basis.
Treatment of <b>Mental, Emotional or Functional Nervous Disorders</b> or psychological testing except as specifically provided in this Policy. However, medical conditions that are caused by behavior of the Insured Person and that may be associated with these mental conditions are not subject to these limitations.
Smoking cessation programs.
Treatment of <b>substance abuse</b> , except as specifically provided in this Policy.
<b>Dental services</b> , dentures, bridges, crowns, caps or other Dental Prostheses, extraction of teeth or treatment to the teeth or gums, except as specifically provided in this Policy.
<b>Orthodontic Services</b> , braces and other orthodontic appliances including orthodontic services for Temporomandibular Joint Dysfunction.
<b>Dental Implants</b> : Dental materials implanted into or on bone or soft tissue or any associated procedure as part of the implantation or removal of dental implants.
Hearing aids, except as specifically stated in this Policy.

Genetic screening or pre-implantations genetic screening: general population-based genetic screening is a testing method performed in the absence of any symptoms or any significant, proven risk factors for genetically linked inheritable disease.
<b>Optometric services</b> , eye exercises including orthoptics, eyeglasses, contact lenses, routine eye exams, and routine eye refractions, except as specifically stated in this Policy.
An <b>eye surgery</b> solely for the purpose of correcting refractive defects of the eye, such as near-sightedness (myopia), astigmatism and/or farsightedness (presbyopia).
Any <b>Drugs</b> , medications, or other substances dispensed or administered in any outpatient setting except as specifically stated in this Policy. This includes, but is not limited to, items dispensed by a Physician.
<b>Cosmetic surgery</b> or other services for beautification, to improve or alter appearance or self esteem or to treat psychological or psychosocial complaints regarding one's appearance including macromastia or gynecomastia surgeries; surgical treatment of varicose veins; abdominoplasty/panniculectomy; rhinoplasty; and blepharoplasty,. This exclusion does not apply to Reconstructive Surgery to restore a bodily function or to correct a deformity caused by Injury or congenital defect of a Newborn child, or for Medically Necessary Reconstructive Surgery performed to restore symmetry incident to a mastectomy.
Aids or devices that assist with nonverbal communication, including but not limited to communication boards, prerecorded speech devices, laptop computers, desktop computers, Personal Digital Assistants (PDAs), Braille typewriters, visual alert systems for the deaf and memory books.
Non-medical counseling or ancillary services, including but not limited to: education, training, vocational rehabilitation, behavioral training, biofeedback, neurofeedback, hypnosis, sleep therapy, employment counseling, back school, return to work services, work hardening programs, driving safety, and services, training, educational therapy or other non- medical ancillary services for learning disabilities and developmental delays.
Services for redundant skin surgery, removal of skin tags, acupressure, acupuncture, carinosacral/cranial therapy, dance therapy, movement therapy, applied kinesiology, rolfing, prolotherapy and extracorporeal shock wave lithotripsy (ESWL) for musculoskeletal and orthopedic conditions, regardless of clinical indications.
Procedures or treatments to change characteristics of the body to those of the opposite sex. This includes any medical, surgical or psychiatric treatment or study related to <b>sex change</b> .
Treatment of <b>sexual dysfunction</b> impotence and/or inadequacy except if this is a result of an Accidental Injury, organic cause, trauma, infection, or congenital disease or anomalies.
All services related to the evaluation or treatment of <b>fertility and/or</b> <b>Infertility</b> , including, but not limited to, all tests, consultations, examinations, medications, invasive, medical, laboratory or surgical procedures including sterilization reversals and In vitro fertilization, except

#### Endnotes

1] "Network" refers to a specified group of physicians, hospitals, medical clinics and other health care providers that Cigna may require in order for you to get any coverage at all under the plan, or that Cigna may encourage you to use because it may pay more of your bill if you use Cigna network providers (i.e., go in-network) than if you don't (i.e., go out-of-network).

2] "Deductible type" indicates whether the deductible period is "Calendar Year" (January 1 through December 31) or "Benefit Year" (i.e., based on a benefit year beginning on the policy's anniversary date) or if the deductible is based on other requirements such as "Per Accident or Injury" or "Per Confinement".

2a] "Deductible" means the amount you will have to pay for allowable covered expenses under a health plan during a specified time period (e.g., calendar year or benefit year) before Cigna will cover those expenses. The specific expenses that are subject to the deductible may vary by policy.

2b] "Individual" means the deductible amount you and each individual covered by the policy will pay for allowable covered expenses before Cigna will begin covering those expenses.

2c] "Family" is the maximum deductible amount that is required to be met for all family members covered by a non-HSA-qualified policy and it may be an aggregated amount (e.g., "\$3,000 per family") or specified as the number of individual deductibles that must be met (e.g., "3 deductibles per family"). "non-single" is the deductible amount that must be met by one or more family members covered by and HSA-qualified plan before any covered expenses are paid.
